RESOLUTION NO.1/42-ORG ON THE OIC PERMANENT REPRESENTATIVES COMMITTEE

The Forty-Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait, on 27-28 May, 2015 (9-10 Shaban 1436H);

Referring to Articles (5) and (13) of the OIC Charter, under which the Permanent Representatives Committee is viewed as one of the OIC's main organs,

Recalling the relevant CFM resolutions latest of which Res. No.2/41 ORG on the Permanent Representatives Committee,

Reaffirming the role played by the Permanent Representatives Committee in boosting the OIC's management capacity as to the issues entrusted to it by the Member States,

Having considered the Secretary General's report as reflected in document OIC/CFM-42/2015/ ORG/SG.REP.1) inclusive of the report of the Permanent Representatives Committee's meeting under document OIC/CPR-1/2014/REP:

- 1. **Expresses** its appreciation to the Permanent Representatives Committee for having started its meetings and invites it to continue its work pursuant to Article (4) of the rules governing its duties.
- 2. **Requests** the Secretary General to report on the implementation of this resolution to the 43rd Session of the Council of Foreign Ministers.

RESOLUTION NO.2/42-ORG ON NGO HUMANITARIAN ORGANIZATIONS' REQUESTS FOR OIC CONSULTATIVE STATUS

The Forty-Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait, on 27-28 May, 2015 (9-10 Shaban 1436H);

Recalling Res. 2/39 ORG which approved the Rules and Regulations for NGO Humanitarian Organizations' accession to the OIC Consultative status and the terms and conditions thereof,

Being aware of the importance of a fruitful cooperation between the OIC and NGO Humanitarian Organizations engaged in programmes and actions of humanitarian character in the Member States or in favour of the Muslim communities and minorities in Non-OIC Member States,

Having taken note that some of the requests submitted by NGO Humanitarian Organizations have met the terms required for access to the consultative status, while some others have not:

Having considered the Secretary General's report as reflected in document OIC/CFM-42/2015/ ORG/SG.REP.2

- 1. **Postpone** decision on granting consultative status to Non-Governmental humanitarian organization because of the current situation in the region.
- 2. **Requests** the Secretary General to report on the implementation of this resolution to the 43rd Session of the Council of Foreign Ministers.

RESOLUTION NO.3/42-ORG

ON RULES FOR GRANTING OIC AFFILIATED INSTITUTION STATUS

The Forty-Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait, on 27-28 May, 2015 (9-10 Shaban 1436H);

<u>Mindful of</u> Articles 22 and 25 of the Charter, concerning the granting of the status of OIC affiliated institution,

<u>Cognizant</u> of the current situation of the OIC affiliated institutions,

Cognizant also of the growing ising interest in acceding to the OIC affiliated status and the increasing requests thereof, in the absence of a legal framework that specifies terms and conditions for admissibility,

Being convinced of the importance of the participation of all impactful players in the Member States towards the achievement of the Organization's objectives as stipulated in its Charter,

Taking note of the Secretary General's report submitted under document no.OIC/CFM-42/2015/ ORG/SG.REP.3.

- 1. <u>Expresses</u> its appreciation to the Secretary General for the work carried out by the General Secretariat for the elaboration of the draft rules for granting the status of OIC affiliated institution.
- 2. <u>Recommends</u> the constitution of an open-ended Intergovernmental Group of Experts to consider the draft rules governing the granting of OIC-affiliated institution status in accordance with the study prepared by the OIC General Secretariat.
- 3. **Requests** the Secretary General to report on the implementation of this resolution to the 43rd Session of the Council of Foreign Ministers.

RESOLUTION NO.4/42-ORG

ON THE REFORM OF THE ORGANIZATION OF ISLAMIC COOPERATION

The Forty-Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait, on 27-28 May, 2015 (9-10 Shaban 1436H);

Referring to the principles and objectives of the Organisation of Islamic Cooperation;

<u>Recalling</u> the recommendations of the 3rd Extraordinary Islamic Summit Conference, held in Makkah Al Mukarramah on 6-7 Dhul Qedah 1426H (7-8 December 2005);

Expressing satisfaction at the progress made in reform, including the amendment of the OIC Charter and the adoption of the Ten-Year Program of Action;

<u>Reaffirming</u> the importance for the Organization to continuously keep pace with the developments taking place at the international level;

Commending the efforts made by Member States and the General Secretariat with a view to ensuring rational management of resources and greater rationalization of the Organization's activities with more focus on the key duties;

Applauding the results achieved in the recent years in the domain of reform of the OIC structures and modernization of its working methods:

- **1.** Commends the results achieved in recent years in the domain of reform of the OIC structures and modernization of its working methods;
- 2. Expresses thanks to the Secretary General for his efforts to reform the Organization.
- **3.** Expresses support for the Secretary General and requests him to prepare a report on priorities for action at the OIC in the next dispensation, in line with the Charter, duties, and basic objectives of the OIC, to ensure greater harmonization between available financial and human resources on one hand, and the OIC's programmes and projects on the other to present the first report next Session.

4. Requests the Secretary General to submit a report on the implementation of this resolution to the 43rd Session of the Council of Foreign Ministers.

RESOLUTION NO.5/42-ORG ON NETWORK LINKING OF THE OIC MEMBER STATES' OMBUDSMEN OFFICES

The Forty-Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism), held in Kuwait, on 27-28 May, 2015 (9-10 Shaban 1436H);

<u>**Guided**</u> by the OIC Member States' firm belief, under the provisions of the OIC charter, as to the need to consolidate human rights, fundamental liberties, good governance, the rule of law, democracy and accountability in the Member States, in line with their respective constitutional and juridical regulations.

<u>Having in mind</u> the provisions of the Ten-Year Program of Action issued by the Third Extraordinary Islamic Summit (7-8 December 2005) which lays emphasizes on the need for diligent action to expand political participation, ensure equality, civil liberties and social justice, promote transparency and accountability, and combat corruption in the OIC Member States.

<u>Also having in mind</u> the final declaration which was issued by the Fourth Extraordinary Islamic Summit (Promotion of Islamic Solidarity) held in Makkah on 14-15 August 2012, and which stresses that reform and development must be accompanied by a healthy management of public affairs based on justice and equality among the citizens of the Islamic Ummah, due observance of laws and regulations, the necessary participation of citizens in running the Ummah's affairs, and paving the way for the emergence of civil society institutions to stimulate the reform and development in the Muslim Society,

<u>Appreciative of the</u> efforts of the Turkish Republic in offering to host the second meeting for the network linking of the OIC Ombudsmen Offices,

Hailing the role of the Islamic Republic of Pakistan in hosting the first meeting of the Network of Ombudsman Offices in the OIC Member States, held in Islamabad, Pakistan on 28-29 April 2014.

<u>Welcoming</u> the meeting of the Steering Committee of the OIC Ombudsman Association (OICCA) on 28-29 April 2015 at Islamabad to finalize by-laws for the Association.
