**RESOLUTION NO.1/42-S&T**  
**ON**  
**SCIENCE AND TECHNOLOGY MATTERS**

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

*Referring to the OIC Vision 1441H for Science and Technology adopted by the Tenth Islamic Summit Conference held in Putrajaya in October 2003 and the OIC Ten Year Programme of Action adopted by the Third Extraordinary Islamic Summit Conference held in Makkah Al-Mukarramah in December 2005;*

*Mindful of the relevant Resolutions adopted by the previous sessions of the Council of Foreign Ministers, including Resolution No 1/41 – S&T on Science and Technology Matters adopted by the 41<sup>st</sup> session held in Jeddah, Kingdom of Saudi Arabia, 18-19 June 2014;*

*Bearing in mind the Final Communiqués adopted by the 4th Extraordinary session of the Islamic Summit Conference, held in Makkah on 14-15 August 2012, and the 12th session of the Islamic Summit Conference held in Cairo on 6-7 February 2013;*

*Welcoming the launch of the country report on Indonesia and the Final Report under the Atlas of Islamic World Science and Innovation project, thus marking the conclusion of the project;*

*Commending the role of the COMSTECH and the activities and programmes of ISESCO, SESRIC, IAS, IDB and ICCI in the field of the development and promotion of science and technology in the Islamic World;*

*Taking note of the efforts of the COMSTECH Secretariat in preparing for the OIC Summit on Science and Technology in coordination with the Government of Pakistan;*

*Having considered the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/42-CFM/2015/ST/SG-REP):*

1. **Calls upon** the Member States and relevant OIC institutions to continue and further strengthen their programmes and activities for the promotion of science, technology and innovation, including efforts for sound STI policy frameworks, promotion of R&D, university-industry linkages, collaboration of joint-R&D projects, public-private partnerships, and measures for enhancing R&D funding;
2. **Urges** COMSTECH to expedite the finalization of the project for STI mapping and foresight studies covering a broad cross-section of OIC Member States and updated at

regular intervals as successor programme to the Atlas of Islamic World Science and Innovation project;

3. **Looks forward** to the convening of the OIC Summit for Science and Technology for identifying priorities, goals and targets for the advancement and promotion of science and technology as a driver for socio-economic development in the OIC Member States;
4. **Urges** all Member States and relevant OIC institutions to participate at the OIC Summit for Science and Technology scheduled to be held in Islamabad during last quarter of 2015;
5. **Calls upon** all relevant OIC institutions to coordinate their programmes and activities with COMSTECH with a view to achieving synergies and complementarities in the pursuit of the objectives outlined by the Summit on Science and Technology;
6. **Welcomes** IDB publication on IDB Prize Winning institutions on S&T and **urges** IDB, COMSTECH and the General Secretariat to identify opportunities among the winning institutions to be centres of excellence for intra-OIC collaboration on S&T;
7. **Requests** IDB to continue supporting initiatives for the promotion of science, technology and innovation, bearing in mind the priorities, goals and targets directly contributing to the achievement of socio-economic development objectives of the Member States;
8. **Invites** the Member States to confirm participation, at their earliest convenience, in the International Specialized Exhibition EXPO-2017, to be held in Kazakhstan, which will be an opportunity for them to present their best practices and technologies in the green energy field”
9. **Requests** the Secretary General to report on the implementation of these recommendations to the next Session of the Council of Foreign Ministers.

**RESOLUTION NO.2/42-S&T**  
**ON**  
**HIGHER EDUCATION MATTERS**

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

*Mindful* of the relevant Resolutions adopted by the previous sessions of the Council of Foreign Ministers, including Resolution No 2/41 – S&T on Higher Education Matters adopted by the 41<sup>st</sup> session held in Jeddah, Kingdom of Saudi Arabia, 18-19 June 2014;

*Bearing in mind* the Final Communiqués adopted by the 4th Extraordinary session of the Islamic Summit Conference, held in Makkah on 14-15 August 2012, and the 12th session of the Islamic Summit Conference held in Cairo on 6-7 February 2013;

*Recalling* the resolutions and decisions adopted by the Islamic Conferences of Higher Education and Scientific Research, including those adopted by the 7<sup>th</sup> Islamic Conference of Ministers of Higher Education and Scientific Research (Rabat, 18-19 December 2014);

*Bearing in mind* the important role of the OIC affiliated universities i.e. Islamic University of Technology (IUT), Dhaka, Bangladesh, Islamic University in Uganda (IUIU), Islamic University in Niger (IUN) and International Islamic University Malaysia (IIUM) in promoting higher education, research and development;

*Welcoming* the successful conduct of the OIC Educational Exchange Programme under which nearly 300 scholarships have so far been announced at graduate, masters, doctoral and post-doctoral levels by various public and private sector universities in the OIC Member States;

*Welcoming* the convening of the 7<sup>th</sup> Islamic Conference of Ministers of Higher Education and Scientific Research in Rabat, Morocco, on 18-19 December 2014;

*Having considered* the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/42-CFM/2015/ST/SG-REP):

1. **Calls upon** the Member States and relevant OIC institutions to continue and further strengthen their programmes and activities in the domain of higher education, including efforts for improvements in curricula, faculties, networking among higher education institutions, promotion of joint research projects, distance learning arrangements, scholarship programmes and vocational training programmes;

2. **Expresses** appreciation for the higher education scholarships offered by Azerbaijan, Brunei Darussalam, Egypt, Turkey and universities from Member States and Observers; COMSATS Institute for Information Technology (CIIT), International Islamic University Malaysia (IIUM), National University of Science and Technology (NUST), Pakistan, University of Lahore (UOL), The Cyprus International University (CIU), The Eastern Mediterranean University (EMU), The European University of Lefke (EUL), The Girne American University (GAU), The Near East University (NEU), The Middle East Technical University METU under the OIC Educational Exchange Programme; and invites Member States to encourage their public and private sector higher education and research institutions to actively collaborate with the OIC for the further strengthening and promoting the OIC Educational Exchange Programme;
3. **Further** invites Member States to widely disseminate for the benefit of interested students information about the ongoing offers of scholarships for the academic session in 2015, which include 10 scholarship offers by the Arab Republic of Egypt, 10 offers by COMSATS Institute of Information Technology, 5 offers by International Islamic University Malaysia and 15 offers by University of Lahore;
4. **Urges** ISESCO and OIC General Secretariat to coordinate their efforts within the frameworks of the OIC Educational Exchange Programme and TAFAHUM project on exchange of students, faculty and researchers among universities in the Islamic World, with a view to establishing a general framework for promoting and advancing higher education through enhanced exchanges, scholarships, sharing of expertise and joint research;
5. **Welcomes** the holding of the first meeting of the High-Level Quality and Accreditation Committee, which was held in May 2014 under the chairmanship of Saudi Arabia, to follow-up on the implementation of the 'Key Performance Indicators for Universities in the Islamic World' and the adoption of the Terms of Reference of the Committee by the 7<sup>th</sup> Islamic Conference of Ministers of Higher Education and Scientific Research (Rabat, 18-19 December 2014);
6. **Appreciates** the efforts of the concerned Member States and the Islamic Development Bank (IDB) for promoting and advancing higher education in Member States, including IDB's support for OIC universities as well as IDB scholarships programmes: Scholarship Programme for Muslim communities in Non-member Countries, M.Sc. Scholarship Programme in Science and Technology for Least Developed Member Countries' and Merit Scholarship Programme for High Technology.
7. **Reaffirms** its support for the efforts of IDB to contribute to the establishment of an International Islamic University in Kabul, Afghanistan, as well as efforts by the Bank to mobilize financial resources for this purpose;

8. **Requests** the Secretary General to report on the implementation of these recommendations to the next Session of the Council of Foreign Ministers.

**RESOLUTION NO.3/42-S&T**  
**ON**  
**HEALTH MATTERS**

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

*Recalling* Resolution No. 3/41 – S&T on Health Matters adopted by the 41<sup>st</sup> session of Council of Foreign Ministers of the Organization of the Islamic Cooperation held in Jeddah, Kingdom of Saudi Arabia, 18-19 June 2014;

*Referring* to the resolutions and decisions adopted by the Islamic Conferences of Health Ministers and the Steering Committee on Health , including those adopted by the 4th Islamic Conference of health Ministers (Jakarta, 22-24 October 2013);

*Bearing* in mind the Final Communiqués adopted by the 4th Extraordinary session of the Islamic Summit Conference, held in Makkah on 14-15 August 2012, and the 12th session of the Islamic Summit Conference held in Cairo on 6-7 February 2013;

*Taking note* of the progress made in the implementation of the OIC Strategic Health Programme of Action (OIC-SHPA) 2014 – 2023;

*Appreciating* the hosting by Turkey of the 2<sup>nd</sup> Meeting of Lead Country Coordinators (LCCs) of the OIC-SHPA (23-24 February 2015) and the 9<sup>th</sup> Meeting of the Steering Committee on Health (25-26 February 2015);

*Taking note* of the establishment of the OIC Vaccine Manufacturers' Group and holding of its first meeting in Jeddah on 25-26 June 2014;

*Appreciating* the convening of a meeting of OIC Ambassadors accredited to the WHO which was held in Geneva on 29 September 2014 under the chairmanship of the then Minister of Health of the Republic of Indonesia to mobilize support for Member States affected by the Ebola Virus Disease (EVD) in West Africa;

*Appreciating* the joint efforts of OIC and IDB in assisting the member states affected by the Ebola Virus Disease EVD in West Africa including the convening of the resource mobilization conference on 05 November 2014;

*Taking note* of holding of the inaugural meeting of the OIC collaborative Project on Maternal and Child Survival Programme in seven selected OIC member states in conjunction with SESRIC, IDB, WHO, UNFPA and USAID, held in Ankara on 19-21 January 2015;



*Further taking note*, with appreciation, of the efforts by Islamic Advisory Group on polio eradication including the convening of International Ulama Conference on child health and immunization in Somalia organized by the OIC, IDB, IIFA and WHO in Khartoum, Republic of Sudan on 28-29 January 2015;

*Welcoming* the progress in the OIC-IDB-IAEA Cooperation project on Support to African Countries' Efforts to tackle Cancer;

*Appreciating* the ongoing cooperation in the field of health between the OIC and international partners such as the World Health Organization, the Global Fund to fight against HIV/AIDS, Tuberculosis and Malaria, the Global Polio Eradication Initiative (GPEI), the Stop TB partnership, the Roll Back Malaria, UNICEF, UNFPA and the GAVI Alliance;

*Having considered* the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/42-CFM/2015/ST/SG-REP):

1. **Calls upon** the Member States to continue their efforts in implementing the OIC Strategic Health Programme of Action (OIC-SHPA) 2014-2023 in coordination with the respective Lead Country Coordinators (LCCs) for each of the six thematic areas of the Programme;
2. **Urges** the OIC General Secretariat to continue coordination with the OIC Technical Committee on Development and Harmonization of Standards of Pharmaceuticals and Vaccines and the OIC Vaccine Manufacturers' Group and the IDB toward promotion of self-reliance in production of vaccines and exploring possibilities for viable and practical mechanisms for Pooling of Procurements of Pharmaceuticals and Vaccines;
3. **Invites** interested vaccine manufacturing companies from OIC Member States to join the OIC Vaccine Manufacturers' Group;
4. **Urges** the OIC General Secretariat in close coordination with the Kingdom of Saudi Arabia to urgently organize meeting of Member States to discuss for Pooling of Procurements of Pharmaceuticals and Vaccines;
5. **Invites** Member States to participate in training sessions on pharmaceutical regulatory system to be organized by Malaysia in November 2015 and further invites the Member States to utilize the WHO Collaborative Centers relevant to various aspects of health;
6. **Welcomes** the contributions of NGOs in implementation of OIC-SHPA 2014 -2023;
7. **Welcomes** the meeting of OIC Ambassadors accredited to the WHO which was held in Geneva on 29 September 2014 under the chairmanship of the then Minister of Health of

the Republic of Indonesia to discuss the Ebola Virus Disease outbreak and takes note on the necessity of immediate actions and continuous solidarity to confront the outbreak;

8. **Welcomes** the OIC-IDB joint efforts in contributing towards international response to the outbreak of Ebola Virus Disease in West Africa and lauds the IDB for the approval of US \$ 10 million as seed money for a special fund dedicated to assisting states to fight Ebola Virus Disease;
9. **Expresses gratitude** for the generous contribution of US \$ 35 million by the Custodian of the Two Holy Mosques King Abdallah bin Abdulaziz (May Allah have mercy on him) towards OIC-IDB efforts to contain the spread of Ebola and **calls upon** other Member States and organizations to contribute towards these efforts;
10. **Requests** participating Member States in the OIC collaborative Project on Maternal and Child Survival Programme to facilitate the work of National Focal Points in collecting and compiling the necessary data on the state of Maternal and Newborn Health Care in their respective jurisdictions;
11. **Further requests** all Member States to continue their efforts to increase coverage of immunization and ensuring all children are vaccinated against preventable diseases in particular polio, as well as to engage in multilateral and bilateral cooperation, including by exchanging epidemiological information, laboratory monitoring data, and carrying out simultaneous supplementary immunization activities as appropriate;
12. **Reiterates** its support for the religious injunctions (Fatwas) of the International Islamic Fiqh Academy regarding the safety and acceptability in Islam of polio vaccination and declaring it a duty of all parents and communities to protect children and to allow health workers to carry out their duties in safety;
13. **Encourages** the Member States to participate and contribute to the OIC-IDB-IAEA joint project on Support to African Countries' Efforts to tackle Cancer;
14. **Urges** the Member States to strengthen cooperation in the area of health training and education including offers of scholarships in the field of health education under the 'OIC Educational Exchange Programme: Promoting Solidarity through Academia';
15. **Urges** the Member States to undertake necessary steps to promote healthy life style and strengthen control of non-communicable diseases including obesity, diabetes and cardiovascular diseases;
16. **Requests** potential donors, including the OIC Member States, to contribute generously to the GPEI and the Global Fund to support activities against polio, HIV/AIDS, tuberculosis and malaria;

17. **Welcomes** the approval by IDB of an amount of Euro 15.00 million for “Support to Yellow Fever Vaccine Production Project in Senegal” out of the total estimated project cost of Euro 23.02 million. The project will address the regional and global demand for yellow Fever Vaccine through increasing its production from 4.5 million to 15-30 million doses per year.
18. **Emphasizes** that in support of national development efforts in the area of health, an enabling international environment, supportive of universal, non-discriminatory, timely and affordable access to medicines, vaccines, equipment, technologies, knowledge and information and other supplies is required to guarantee comprehensive provision of health care services for women, children, adolescents, elderly and other groups in vulnerable situation;
19. **Urges** the Member States to ensure that health is central to the post-2015 development agenda;
20. **Encourages** all Member States to actively participate in the 5<sup>th</sup> Islamic Conference of Health Ministers to be held in Turkey in November 2015;
21. **Requests** the Secretary General to report on the implementation of these recommendations to the next Session of the Council of Foreign Ministers.

**RESOLUTION NO.4/42-S&T  
ON  
ENVIRONMENT MATTERS**

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

*Reaffirming* the relevant Resolutions adopted by the previous sessions of the Council of Foreign Ministers, including Resolution No 4/41 – S&T on Environment Matters adopted by the 41<sup>st</sup> session held in Jeddah, Kingdom of Saudi Arabia, 18-19 June 2014;

*Taking into account* the resolutions of the 5th Islamic Conference of Environment Ministers held in Astana, Kazakhstan, from 17-18 May 2012 and the Islamic Declaration for Sustainable Development (within the Framework of the Islamic World's Participation in the Rio+20 Summit) adopted by the Conference;

*Bearing in mind* the Final Communiqués adopted by the 4th Extraordinary session of the Islamic Summit Conference, held in Makkah on 14-15 August 2012, and the 12th session of the Islamic Summit Conference held in Cairo on 6-7 February 2013;

*Reiterating* the importance of a transparent and inclusive inter-governmental negotiation process within the United Nations General Assembly on sustainable development goals and Post-2015 development agenda;

*Having considered* the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/42-CFM/2015/ST/SG-REP):

1. **Calls upon** the Member States to implement the decisions, resolutions and recommendations of the Islamic Conferences of the Environment Ministers, including the 4<sup>th</sup> Islamic Conference of Environment Ministers held in Astana, Kazakhstan, from 17-18 May 2012;
2. **Reiterates** the need for robust global cooperation, especially for countries vulnerable to adverse consequences of climate change, including additional, adequate and predictable financing and technology development and transfer, capacity building from developed to developing countries, under the UN Convention on Climate Change and the Kyoto Protocol. The provision of finance should be in addition to the existing commitments for official development assistance.
3. **Calls upon** Member States to undertake consultations and coordinate their positions to effectively address challenges stemming from climate change and deteriorating

environmental conditions, develop environmental policies and allocate necessary human, technological and economic resources for this purpose so as to make a unified, substantial contribution in these processes;

4. **Urges** the Member States to actively participate and coordinate their positions, as appropriate, in all relevant processes of developing a new document, successor to the Kyoto Protocol at the international level, due to its impact on the development agenda of the developing countries;
5. **Invites** the Member states to continue their engagement and participation in a coordinated manner in the ongoing negotiation process under the auspices of the UN General Assembly for the finalization of the post-2015 development agenda and Sustainable Development Goals;
6. **Calls upon** COMSTECH to expedite the finalization of the OIC Green Technology Blue Print in collaboration with the Universiti Teknologi Malaysia (UTM) and the Islamic Development Bank (IDB);
7. **Requests** COMSTECH to accord special attention to the promotion of cooperation among the Member States and related OIC institutions in areas such as environment protection, renewable energies and green technology and effective utilization of existing expertise in the Member States in such fields;
8. **Requests** the Secretary General to report on the implementation of these recommendations to the next Session of the Council of Foreign Ministers.

**RESOLUTION NO.5/42-S&T**  
**ON**  
**OIC WATER VISION**

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

*Reaffirming* Resolution No 5/41–S&T on OIC Water Vision adopted by the 41<sup>st</sup> session of Council of Foreign Ministers 41<sup>st</sup> session held in Jeddah, Kingdom of Saudi Arabia, 18-19 June 2014;

*Bearing in mind* the Final Communiqués adopted by the 4th Extraordinary session of the Islamic Summit Conference, held in Makkah on 14-15 August 2012, and the 12th session of the Islamic Summit Conference held in Cairo on 6-7 February 2013;

*Taking note* of the resolution and recommendations of the 2<sup>nd</sup> Islamic Conference of Ministers Responsible for Water (Istanbul, Turkey, 5 – 6 March 2012) which adopted the OIC Water Vision;

*Underscoring* the significance of cooperation between the OIC Member States for the implementation of the OIC Water Vision including cooperation to ensure access to safe drinking water and sanitation;

*Having considered* the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/42-CFM/2015/ST/SG-REP):

1. **Welcomes** the appointment of national focal points to coordinate the implementation of the OIC Water Vision by a large number of Member States and **requests** the Member States, which have not yet done so, to designate and convey the contact details of their respective national focal points to the OIC General Secretariat at the earliest possible;
2. **Welcomes** the establishment by SESRIC of a web portal on water resources to collate information from Member States on their needs and offers for cooperation and the development of a specific water resources capacity building questionnaire for this purpose and encourages the Member States to share information with SESRIC as appropriate;
3. **Invites** Member States to utilize the opportunities for capacity building and human resource development available under the SESRIC Water Resources Management Capacity Building Programme (Water-CaB) which aims at facilitating exchange of knowledge, experience and best practices in the domain of water among the member countries and thus contributing to the implementation of OIC Water Vision;

4. **Welcomes** the offer by Turkey to convene 1<sup>st</sup> Meeting of National Focal Points in June 2015 to consider concrete measures for the implementation of the OIC Water Vision, focusing on exchange and knowledge sharing; collaborative activities in research, policy and management support amongst OIC knowledge centers on water; capacity building and enhancement, outreach development; and organization of specialized forums and conferences;
5. **Further welcomes** the offer of the Republic of Turkey to host the Third Islamic Conference of Ministers Responsible for Water on 2 – 4 November 2015 in Istanbul;
6. **Requests** the Secretary General to report on the implementation of these recommendations to the next Session of the Council of Foreign Ministers.

*Bearing in mind* the resolutions adopted by the successive sessions of the Council of Foreign Ministers including Resolution No. 6/41-S&T on the Activities of Standing Committee on Scientific and Technological Cooperation (COMSTECH) adopted by the 41<sup>st</sup> session held in Jeddah, Kingdom of Saudi Arabia on 18-19 June 2014;

*Mindful* of the recommendation of the 29<sup>th</sup> Meeting of the Executive Committee of COMSTECH held at Baku, Republic of Azerbaijan on 25-26 November 2011;

*Expressing* profound gratitude to the Governments of Bangladesh, Malaysia, Niger and Uganda for their continued support for the respective OIC universities;

*Expressing* gratitude to the OIC Member States for their support and provision of assistance to the OIC universities including contributions to the relevant Waqfs;

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

*Referring to the objectives and principles of the Charter of the Organization of the Islamic Cooperation where it demands the Member States to Endeavour to protect and preserve the environment;*

*Having considered the OIC Ten-Year Program of Action calling upon Member States to coordinate their environmental policies and positions in international environmental fora so as to prevent adverse effects of such policies on their economic development;*

*Recalling Resolution on the implementation of the OIC Ten-Year Programme of action, underlining the need to ensure sustainable development of Member States through effective policy to protect the environment;*

*Recalling further article 3 of the Islamic Declaration on Sustainable Development, ratified by Islamic Environment Ministers in Jeddah, on 10-12 June 2002, where it names the environment a gift from Allah and calls upon all individuals and communities to take care of it and promote it;*

*Taking into account the adverse effects of severe and long-standing drought and implications of climate change, in the shape of dust and sand storm in certain Member States;*

*Further taking into account the final report of the First Meeting of the Islamic Executive Bureau for Environment which, among other things, calls on Member States competent authorities to redouble efforts and better coordinate actions to meet the new challenges posed by climate change and deterioration of environmental situation including desertification;*

*Recalling Resolution No. 9/40-S&T on Mainstreaming Efforts to Combat the Sand and Dust Storm adopted by the 41<sup>st</sup> session of the Council of Foreign Ministers held in Jeddah, Kingdom of Saudi Arabia, 18-19 June 2014;*

*Welcoming the UNEP initiative of Regional Programme to Combat Sand and Dust Storms including Ministerial Meeting held in Nairobi on 21 February 2013 and the Technical Meeting held in Abu Dhabi on 6-7 May 2013, attended by more than 50 countries, relevant UN agencies, regional organizations and other participants;*

1. **Expresses** concern over the unprecedented wave of sand and dust tempests and for the considerable losses they have been causing in desert areas in the Member States in both Asia and Africa;
2. **Calls** on all the Member States affected in desert areas in Asia and Africa to engage in a conscientious and constructive interaction to resolve this problem in an appropriate manner;
3. **Appreciates** the participation of the OIC Member States in the UNEP regional project on Catalyzing Cooperative Actions to Combat Land Degradation and Dust Storms under the UNEP initiative of Regional Programme to Combat Sand and Dust Storms and encourages other OIC Member States to join the UNEP regional project;
4. **Expresses** appreciation for the efforts to limit sandstorms and drought in states of the region under the umbrella of a programme developed by the World Meteorological Organization in the context of limiting the impact of climate change;
5. **Appreciates further** the UAE for hosting the Technical Meeting held in Abu Dhabi on 6-7 May 2013;
6. **Expresses** its support for developing a collective regional mechanism for awareness raising early warning and risk management network enabling the affected countries to face the problem in a suitable manner;
7. **Calls upon** all international and regional environmental instruments and institutions, including ROPME, to seriously and rapidly address the issue and to mobilize their resources, both technically and financially to assist the affected countries;
8. **Invites** the Member States to contribute to the reforestation of desert zones in the OIC Member States, and to take firm measures against the abusive cutting of trees and bushfires;
9. **Invites** the OIC Specialized Agencies such as Islamic Development Bank to take all appropriate measures to develop concrete projects for assisting the affected countries enabling them to overcome the disastrous effects of this phenomenon;
10. **Decides** to remain seized with the matter.

**THE FORMER SEMIPALATINSK**  
**NUCLEAR TEST SITE AND THE INTERNATIONAL DAY AGAINST NUCLEAR**  
**TESTS AND REHABILITATION OF THE ARAL SEA REGION**

*The Forty Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait city, State of Kuwait on 9-10 Shaban 1436H (Corresponding to 27-28 May 2015),*

**Taking into consideration** United Nations General Assembly resolution 64/35 “International cooperation and coordination for the human and ecological rehabilitation and economic development of the Semipalatinsk region of Kazakhstan”;

**Taking into consideration also** United Nations General Assembly resolution 63/279 “International Day against Nuclear Tests”, declaring 29 August as the International Day against Nuclear Tests;

**Recalling** resolution No.4/33-S&T on environmental issues adopted by the 33<sup>rd</sup> Session of the Council of Foreign Ministers, requesting the Islamic Development Bank and charity foundations of the Muslim countries to explore ways and means to evolve a programme providing support to the regions of the Aral Sea and Semipalatinsk in coordination with existing international, regional and national programmes;

**Expressing** serious concern over the consequences of ecological problems of the Aral Sea and former Semipalatinsk Nuclear Testing Site;

**Taking note** of the President of the Republic of Kazakhstan NursultanNazarbayev’s decree of 29 August 1991, the Semipalatinsk Nuclear Test Site had been shut down, having functioned from 1949 to 1991 and produced 456 nuclear tests;

**Acknowledging** that the former Semipalatinsk Nuclear Test Site remains an issue of serious concern for Kazakhstan, in view of its long term hazardous effects on the lives and health of the region’s inhabitants and the environment;

1. **Reiterates** its call upon Member States to observe the International Day against Nuclear Tests on 29 August in order to increase awareness of the effects of nuclear weapons test explosions;
2. **Commends** Member States for their contribution to the commemoration of the 20<sup>th</sup> anniversary of the closing of the former Semipalatinsk Nuclear Test site which was aimed at informing the public about the dangerous consequences of nuclear tests for the lives and health of people and the state of the environment;

3. **Emphasizes** importance of implementation of the Third Aral Sea Basin Program-3 (ASBP-3) at the Donor Coordination Conference held on December 9, 2010, in Almaty, Kazakhstan in terms of environment protection;
4. **Commends** the Government of Kazakhstan for implementation of the Field Program “ZhasylDamu” (Green Development) for 2010-2014 directed to comprehensively resolve the issues of region of the former Semipalatinsk Nuclear Testing Site;
5. **Urges** the Islamic Development Bank, the OIC Member States and international donor organizations to continue providing necessary technical and financial support in implementation of Programs directed to address the issues of the Aral Sea and region of the former Semipalatinsk Nuclear Testing Site;
6. **Requests** the Secretary General to submit a report on the implementation of this resolution to the 41th session of Council of Foreign Ministers.
