RESOLUTION 1/43-POA ON THE OIC-2025: PROGRAMME OF ACTION

The Forty-Third Session of the Council of Foreign Ministers of the Organisation of Islamic Cooperation (Session of Education and Enlightenment – Path to Peace and Creation) held in Tashkent 18-19 October 2016 (17-18 Muharram (1438H);

Referring to the objectives and principles enshrined in the Charter of the Organisation of Islamic Cooperation;

Recalling the Declaration of the Third Extraordinary Session of the Islamic Summit Conference, held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia, on 6 to 7 Dhul Qeadah 1426H (7-8 December 2005) adopting the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21st Century;

Further recalling its Resolution 1/41-TYPOA on Implementation of the OIC Ten-Year Programme of Action adopted by the 41st Session of the Council of Foreign Ministers (Jeddah, 18-19 June 2014) welcoming the proposal to elaborate a new OIC Programme of Action 2016-2025 and called upon the Secretary General to propose a draft programme while taking into account contributions by all OIC organs and institutions;

Recognizing the significance of the TYPOA in providing the Islamic Ummah with a forward-looking blueprint with a view to enhancing joint Islamic action;

Bearing in mind its Resolution 1/42-POA on developing the OIC-2025: Programme of Action adopted by the 42nd Session of the Council of Foreign Ministers (Kuwait, 27-28 May 2015) requesting the Secretary General to continue to facilitate the work of the Intergovernmental Experts Group Meeting and submit an implementation report to the 13th session of Islamic Summit Conference (Istanbul, 14-15 April 2016);

Appreciating the support and assistance extended by the Member States, OIC Institutions including subsidiary, specialized, affiliated, Standing committees, international partners and other relevant bodies in the implementation of the TYPOA which concluded in December 2015;

Further appreciating the steps taken by the OIC General Secretariat including the holding of the Consultative Meeting of the OIC Institutions (Jeddah, 7-8 December 2014) and the series of Intergovernmental OIC Experts Group Meetings, Senior Officials Meetings and Foreign Ministers Meeting preparatory to the 13th Islamic Summit Conference, (10-13 April 2016) for the purpose of elaborating the new OIC Programme of Action 2016-2025;

Taking note of the Final Communiqué of the 13th Islamic Summit of the Heads of State/ Government of the OIC Member States (Istanbul, 14-15 April 2016) adopting the OIC-2025: Programme of Action for the next decade;

Having considered the Report of the Secretary General (OIC/CFM-43/2016/POA/SG-REP) on the subject;

- 1. **Calls upon** the Member States, the OIC organs and institutions, international partners as well as other stakeholders to undertake all necessary measures for its effective implementation;
- 2. **Further calls upon** the Secretary General to continue to take necessary steps in this regard;
- 3. **Requests** the Secretary General to report on the implementation of this resolution to the 44th Session of the Council of Foreign Ministers scheduled to be held in the Republic of Guinea in 2017 for consideration.
