ON

THE OIC-2025: PROGRAMME OF ACTION

The Forty-Fourth Session of the Council of Foreign Ministers of the Organisation of Islamic Cooperation (Session of Youth, Peace and Development in a World of Solidarity) held in Abidjan, Republic of Cote d'Ivoire, from 16 to 17 Shawwal 1438H(10-11July 2017);

Referring to the objectives and principles enshrined in the Charter of the Organisation of Islamic Cooperation;

Recalling the Declaration of the Third Extraordinary Session of the Islamic Summit Conference, held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia, on 6 to 7 Dhul Qeadah 1426H (7-8 December 2005) adopting the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21st Century;

Appreciating the support and assistance extended by the Member States, OIC Institutions including subsidiary, specialized, affiliated, Standing committees, international partners and other relevant bodies in the implementation of the TYPOA which concluded in December 2015;

Further appreciating the steps taken by the OIC General Secretariat including the holding of the Consultative Meeting of the OIC Institutions (Jeddah, 7-8 December 2014) and the series of Intergovernmental OIC Experts Group Meetings, Senior Officials Meetings and Foreign Ministers Meeting preparatory to the 13th Islamic Summit Conference, (10-13 April 2016) for the purpose of elaborating the new OIC Programme of Action 2016-2025;

Taking note of the Final Communiqué of the 13th Islamic Summit Conference (Istanbul, 14-15 April 2016) adopting the OIC-2025: Programme of Action; and the

Istanbul Declaration welcoming the adoption of the document setting ambitious targets in various fields for the Member States of the OIC to achieve in the next ten years;

Having considered the Report of the Secretary General on the subject and taking note of the Implementation Plan detailing programmes and activities in terms of 107 goals identified under 18 priority areas, emanating from the summit declarations, CFM resolutions, sectoral ministerial meetings, standing committees and work programmes of the OIC institutions, contained in document OIC/CFM-44/2017/POA/SG-REP and its Annex;

- 1. Calls upon the Member States, the OIC organs and institutions, United Nations and its specialized agencies as well as other stakeholders to undertake all necessary measures for effective implementation of the Programme of Action;
- **2. Further calls upon** the Secretary General to invite inputs of the Member States, relevant OIC institutions including the Standing committees for further development of the Implementation Plan and accordingly prepare a progress report on the implementation of the OIC-2025;
- **3. Requests** the Secretary General to report on the implementation of this resolution to the 45th Session of the Council of Foreign Ministers scheduled to be held in the People's Republic of Bangladesh in 2018 for consideration.
